

ORDINANCE NO 210-20

AN APPROPRIATIONS ORDINANCE FOR THE CITY OF
UNION CITY, TENNESSEE, FOR FISCAL YEAR
BEGINNING JULY 1, 2019 AND ENDING JUNE 30, 2020

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF UNION CITY, THAT:

SECTION 1. The following appropriations for the fiscal year beginning July 1, 2019, and ending June 30, 2020, be and the same are hereby made for the operation of the several departments of the City of Union City, Tennessee, by funds as follows:


SECTION 2. Such salaries as the Council is required to fix by Ordinance are hereby fixed as set forth in the detailed budget estimate for the respective department.

SECTION 3. All Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance be and the same are hereby repealed.

SECTION 4. The provisions of this Ordinance are hereby declared to be severable. If any of its sections, provisions, exceptions, sentences, clauses, phrases, or parts be held unconstitutional or void, the remainder of this Ordinance shall continue in full force and effect, it being the intent now hereby declared that this Ordinance would have been adopted even if such unconstitutional or void matter had not been included therein.

SECTION 6. This Ordinance shall take effect August 27, 2019.
